

INVITATION FOR BIDS

Hiring the Implementation Services for
Matching Grants Scheme (MGS)

Chief Technical Advisor, Agriculture Delivery Unit, Punjab Agriculture Department has earmarked budget towards the cost for provision of incentives in the form of matching grants to attract investment in agriculture value chain and innovative agricultural businesses in Punjab. It is intended that part of the proceeds of this budget will be applied to eligible payments for provision of following services:

Chief Technical Advisor, ADU, invites sealed bids for the provision of above-mentioned services from eligible bidders who are on Active Taxpayers List of the Federal Board of Revenue and registered with Security Exchange Commission of Pakistan, Registrar of Firms, or any other relevant forum in Pakistan.
3. Bidding shall be conducted through Open Competitive Bidding Single Stage-Two Envelop procedure as specified in the Punjab Procurement Rules-2014 (as amended to date) and is open to all eligible bidders as defined in the bidding document.
4. Interested eligible bidders may obtain bidding documents IMMEDIATELY from Chief Technical Advisor (ADU) Punjab 21-Davis Road Lahore during office hours after payment of PKR 500/-.
5. Sealed Bids must be delivered to the above office on or before, **25 February 2020 11:00 AM. Technical Proposals** must be accompanied by a Bid Security as mentioned above in the form of Pay Order or Call at Deposit duly issued from a Scheduled Bank of Pakistan.
6. A pre-bid meeting shall be held on **18 February 2020 at 11:00 AM** in the office of the Chief Technical Advisor, Agriculture Delivery Unit, 21-Davis Road, Lahore to address all queries regarding the bidding documents and the bidding process.
7. Bids will be opened on **25 February 2020 11:30 AM** in the presence of bidders or their representatives in the office of the Chief Technical Advisor, Agriculture Delivery Unit, 21-Davis Road Lahore.
8. The bidders are required to give their best and final prices (inclusive of all applicable Taxes) as no negotiations are expected.
9. Proposal not complying with the requirements shall be rejected being nonresponsive. Alternate proposals and / or conditional bids shall be considered nonresponsive.
10. Taxes will be deducted as per applicable government rules. Bid Security and NTN registration certificate must be provided with the Technical Proposal.
11. Bids which are incomplete, not sealed, not signed and / or not stamped, late or submitted by other than specified mode will be rejected.
12. Bidding documents, obtained / purchased only from Chief Technical Advisor (ADU), Agriculture House, 21-Davis Road, Lahore, Pakistan. will be considered for further processing.
